# Panic at the Discourse Style Guide

This guide serves to answer frequently asked questions about the style requirements for documents presented to *Panic*. If in doubt, refer to the *Chicago Manual of Style* as we closely follow this style guide.

# General

# Set-up

#### Document

- 8 1/2 by 11 (US Letter) size
- One-inch (1") margins
- 12 pt Times New Roman font, doubled-spaced
- No page numbers.

#### **First Page**

- Article title and author name centre aligned at the top of the first page.
- Immediately following title, include a maximum 130-word abstract.
- Include up to 5 keywords after the abstract.
- Maximum 50-word author biography as first endnote.

# **Paragraph Formatting**

#### **Paragraph Indenting**

- First paragraph of a section is not indented.
- Subsequent paragraphs are indented.

### Justification

Left Justification

#### Quotes

- Quotes under 40 words should be included in text using "quotation marks".
- Quotes of more than 40 words, quotation marks are not required but the text must be set off from the main part of the document in a block quote.
- Block quote: alignment Justify, indentation left 0.5, indentation right 0.5

- Punctuation marks should appear inside the quotation marks. For example, it should read "As you wish." rather than "As you wish".
- All quotes must be properly referenced in the endnotes.

### Permissions

• Author must obtain permissions for all included figures.

## **Endnote References**

- Use endnotes for all scholarly and informal sources.
- References listed under "Notes" at the end of the manuscript.
- In-text citations should be superscript Arabic numerals.
- Only one place of publication is necessary for books.
- Remove all hyperlinks.
- Include page numbers for direct quotes.
- Use en-dashes between number ranges; e.g. 123–156.
- Include all three decimal places in number ranges; e.g. 182–185
- Use full reference for first citation, ibid. for immediately repeated citations, and shortened references for later mentions.

# **Figures and Illustrations**

### Labels

- Labels for figures and illustrations are placed below them.
- Provides a text explanation of the visual.
- Should be formatted as complete sentences with capitalization and punctuation.
- Include a credit line.

#### Label Style

- Times New Roman
- 10 pt
- Font style: Bold for Label and Number
- Alignment left

• Numbering using the words Figure, and the Capital Arabic Number, such as; Figure: 1., Figure: 2., Figure: 3.

Label Citation/Credit Line

- Any figure must be cited
- Provide pertinent identifying information, e.g. Author/Title, Date.
